Prerequisites: MAT 531 or graduate standing in the mathematical sciences.

Course Description: Theory of groups, rings, and fields, including the integers and polynomial rings.

The objective of this course is to provide an introduction to modern abstract algebra, primarily groups and rings, and to the axiomatic treatment of mathematics. This course is proof-based and is primarily intended for mathematics majors.

We will cover most of chapters 1–11 (groups) and 12–15 (rings) from the textbook, with some additions and some omissions.

Homework and quizzes: Homework sets will be assigned weekly. They will not be collected, but *these homework assignments are crucial to your learning experience in the course*. There will be weekly in-class quizzes based on the homework problems. The problems will be a mixture of problem-solving and formal proofs.

You are always welcome, in fact encouraged, to ask questions about homework in class and in office hours.

Learning outcomes: In addition to learning the basic theory of groups and rings, the student should learn how to read, understand and write proofs and other abstract mathematical arguments based on axioms and rules of logic.
