- Topics:** Systems of linear equations, linear transformations, matrix and vector algebra, determinants, finite-dimensional Euclidean spaces and their associated geometry, eigenvalues and eigenvectors, matrix diagonalization, the Gram-Schmidt process, selected applications as time allows.
- Restrictions:** Credit will not be given for both MAT 331 and MAT 485.
- Prerequisites:** MAT 286 or MAT 296

- Calculator Policy:** You are allowed to use a graphing calculator (such as TI-84, TI-85) on homework, quizzes, and exams for this class. Students will usually need to show work to receive full credit and some exam or quiz questions will be designated “no calculator”. The use of a symbolic calculator (such as the TI-89 or the TI-Nspire with CAS) is not allowed on quizzes or exams.
- Homework/Quizzes:** Homework will be assigned in class (see page 3). A policy for quizzes and homework collected for grading will be announced before the first collection of assignments is due. In general, late homework will not be accepted.
- Grading:** There will be three exams, on the 2nd, 4th, and 6th Thursday of the course (unless agreed otherwise). Each will count 25% of your grade. There will be considerable homework counting the remaining 25% of your grade. There will be no make-up exams.
- Final Exam Date:** The third exam mentioned above will be considered our final exam. It will be given during the last scheduled class meeting, 11 August 2016, and at no other time. It will cover mainly recent material but may include important topics from earlier in the course.
