Course Prerequisites: MAT 412 or MAT 511 or graduate standing in Mathematical Sciences

Course Description: Complex numbers, topology of the complex plane, analytic functions and the Cauchy-Riemann equations, integration and Cauchy's theorem, Taylor and Laurent series, residues.

Textbook: Complex Analysis, by Ian Stewart and David Tall, Cambridge University Press 1983. We will cover most of Chapters 1-8 and 10-12.

Grading: The course grade will be based on 2 semester exams (25% each, given in class), a final exam (30%), and homework problems (20%). There will be no make-up exams and late homework will not be accepted. All exams are closed books and closed notes. The final exam is comprehensive.

Exam Dates: The dates for midterms will be announced later in class. The final exam is on May 10, 2017 from 8am to 10am.

Homework: Solving the homework problems is crucial for succeeding in this course. Assignments will be collected regularly, as announced in class. It is important that after each class you read and understand the material covered from the textbook and your notes.

Class Attendance and Participation: You are expected to attend and participate in class. Missing class is the most common reason for poor performance in the course. If you must miss a class, you are responsible for obtaining notes for that class from a student who attended. It is also your responsibility to find out about any announcements made in class.
