Textbook: *Advanced Calculus*, Gerald. B. Folland. We will cover parts of chapters 1-5. Topics include, completeness, compactness, connectedness, differentiability of transformations between Euclidean spaces, Taylor's theorem, extreme value problems, implicit function theorem, inverse function theorem, curves and surfaces, integration in higher dimensions, change of variables for multiple integrals. Finishing with the main point of the course: line and surface integrals, Green's theorem, Divergence theorem, Stokes theorem. **Prerequisites:** MAT331 and MAT397.

Grading: There will be two semester exams (25% each) on September 25 and October 30, the final exam (30%) and weekly homework/quizzes (20%). The final exam will be cumulative, and given the scheduled time, see my slice. There will be **no make-ups** for the test or final exam. If you have an excused absence for one of the tests, your grade on the relevant portion of the final will be used.
