Course Content

Catalog Description: Measure and integration, including basic theorems on integration and differentiation of sequences of functions; modes of convergence, product measures. *Prereq.:* MAT 602.

Course outline:

1. Lebesgue measure in \mathbb{R}^n : outer measure, measurable and non-measurable sets, Lipschitz transformations. (7 class periods, sections 3.1–3.6)
2. Measurable functions in \mathbb{R}^n : properties, modes of convergence, theorems of Egorov and Lusin theorems. (5 class periods, sections 4.1–4.4)
3. Lebesgue integral in \mathbb{R}^n : properties, convergence theorems, relation to Riemann and Riemann-Stieltjes integrals. (6 class periods, sections 5.1–5.5)
4. Repeated integration in \mathbb{R}^n : theorems of Fubini and Tonelli, applications. (4 class periods, sections 6.1–6.3)
5. L^p spaces in \mathbb{R}^n : Hölder's and Minkowski's inequalities, sequence spaces, Banach and metric space properties, orthogonality in L^2 . (5 class periods, sections 8.1–8.5)
6. Abstract measure spaces: generalization of the topics listed above, absolutely continuous and singular measures, the dual space of L^p . (6 class periods, sections 10.1–10.4)
7. Differentiation in \mathbb{R}^n : indefinite integral, Lebesgue's differentiation theorem, Vitali covering lemma, the differentiation of monotone functions. (5 class periods, sections 7.1–7.4)

Course Policies

Grading. The grades will be based on homework (40%), quizzes (5%), one midterm exam (25%), and final exam (30%). The grading scheme will be no stricter than: 93 for A, 90 for A-, 87 for B+, 83 for B, 80 for B-, 77 for C+, 73 for C, 70 for C-, 60 for D.

Homework will be assigned and collected electronically on the website Overleaf.com. You are encouraged to discuss the homework problems with your classmates and to work together, but submitted assignments must be written up individually. Two lowest homework scores will be dropped.

Quizzes will be given at the beginning of class, and will be based on the material of previous class. Each quiz will consist of one True/False question. Two lowest quiz scores will be dropped.

Midterm Exam will be in class on **Friday October 12**. The time and place of the **Final Exam** will be announced in class. There will be no make-ups: a missed exam counts as zero unless you present a valid excuse from a physician or the Dean's office. If the absence is excused, your final exam grade will be used to replace the missed exam.

Tips for success in this course:

- It is absolutely essential that you understand how to solve all the assigned problems. Once you understand how to solve a problem, write your solution down neatly and in full detail with explanations that make your reasoning clear.
- Don't fall behind. If you are having difficulties keeping up with the material, see me immediately to discuss the problem.
- Ask questions: in class, after class, during office hours, or by email.
