**Course Description:** The McKay Correspondence brings together group theory, representations, algebraic geometry, noncommutative algebraic geometry, and commutative and noncommutative algebra. The course will trace the relationships between these fields in the various contexts of: finite subgroups of  $SU(2)$ , McKay's observation in character theory, resolutions of singularities of rational double points, reflexive modules, and finite Cohen–Macaulay type.

**Textbook:** Your course notes will be the main resource. Supplementary sources will be mentioned.

**Learning Outcomes:** The students will gain exposure to a variety of mathematical contexts.

**Grading:** Course grade will be based on class participation.
