**Homework:** Each week there will be a **quiz** based on assigned exercises from the section(s) covered in previous classes. You are encouraged to ask questions about problems you are having trouble with the day after they are assigned. There should be ample class time to discuss any difficulties with homework problems. **Working many problems is essential for learning mathematics!** We may also assign and collect problems for grading. No late homework will be accepted. In this case you are encouraged to discuss assigned problems with your classmates and work together. However, the solutions you submit for grading must be written (completely) by you, and not copied from any source. You must write solutions neatly, literately, and in a logical coherent manner on standard 8.5x11 paper.

**Quizzes:** Weekly.

**Exams:** There will be two midterm exams and a final exam. No make-up exams will be given. The midterm exams are scheduled for **February 22** and **April 5**. The **final exam** is scheduled for **Thursday, May 3, 8 am-10 am** in **Lyman Hall 126**. Do not make plans to leave campus before this time.

**Grading:** The following grading scheme will be used. Homework/quizzes 25%, each midterm exam 25%, final exam 25%.

**Attendance and Participation:** You are expected to attend class. If you miss a class you are responsible for obtaining notes for that class from a student who attended. It is also your responsibility to find out about any announcements made in class.
