8. **Homework and Quiz:** Homework will be assigned after each Wednesday class. There will be a quiz at the beginning of most lectures. It will cover the previous lecture and may have a programming component (i.e., you may be asked to write a MATLAB program on paper).

9. **Exams:** There will be two in-class examinations and one final examination during the semester. There will be absolutely no make-ups for any reason.
