Course Content

Catalog Description: Measure and integration, random variables and their distributions and transforms, modes of convergence, classical limit laws. *Prereq.*: MAT 701.

Textbook: *Probability, Theory and Examples,* 4th ed., by Richard Durrett, *Cambridge University Press.*

Course outline: Chapters 1-4, plus additional selected topics, time permitting.

- 1. Measure theory: Probability spaces, distributions, random variables, integration, properties of the integral, expected value, product measures, Fubini's theorem.
- 2. Laws of large numbers: Independence, weak laws of large numbers, Borel-Cantelli lemmas, strong law of large numbers, convergence of random series.
- 3. Central limit theorems: De Moivre-Laplace theorem, weak convergence, characteristic functions, central limit theorems, Poisson convergence.
- 4. Random walks: stopping times, recurrence

Course Policies

Grading: Course grades will be based on homework (30%), a class presentation (10%), two midterm exams (40%), and a final exam (20%). The grading scheme will be no stricter than: 93 for A, 90 for A-, 87 for B+, 83 for B, 80 for B-, 77 for C+, 73 for C, 70 for C-, 60 for D.

Homework: You are encouraged to discuss the homework problems with your classmates and to work together, and also to get help from Prof. Cox. Submitted assignments must be written up individually, in LaTeX, and submitted via email.

Midterm Exams will be given on Wed, Feb 20, 7-9pm, and on Wed April 10, 7-9pm. The final exam will be a take-home exam, details to be announced in class later in the semester.
