You may consult other books or publications except that you may not consult any source that specifically solves problems from the Hartshorne text.

Learning Outcomes

Learn the material in the indicated sections of the textbook. Become familiar with the basic objects in algebraic geometry: algebraic varieties in affine and projective space, Zariski topology, dimension of algebraic varieties, regular and rational maps between algebraic varieties, singular and nonsingular algebraic varieties, tangent spaces to algebraic varieties, basic intersection theory, sheaves, schemes, and cohomology.
