Textbook: Every lecture will be either a beamer presentation or a document projector presentation. No particular text book will be used. Handouts for the presented lectures will be provided.

Course Description: The course is designed to gain insights into advances in Geometric Function Theory (GFT), Nonlinear Partial Differential Equations (PDEs) and Calculus of Variations (CV) with applied disciplines in mind. This includes basic concepts in mathematical models of Nonlinear Elasticity (NE) (the energy-minimal deformations and the principle of non-interpenetration of matter), Harmonic Mappings, Minimal Surfaces, and so forth. We shall begin with Sobolev spaces. The basic idea for defining a Sobolev space consists in using weak derivatives of locally integrable functions; more generally, Schwartz distributions which permit one to define as many derivatives as one may want. The latter is facilitated by functional analysis developed for that purpose (like Radon measures). The concepts of Null Lagrangians and Free Lagrangians that we shall introduce are effective tools in establishing existence, uniqueness and regularity results for assorted energy integrals.

The selection of topics is intended to attract graduate students (also postdoctoral scholars) to Geometric Analysis with a wide range of applications, and to help them to mature meaningful interaction with physicists and engineers already in their doctoral and postdoctoral phase.

Prerequisites: Graduate standing in mathematical sciences. To make this course available to students whose mathematical knowledge may be limited, every efforts will be made to reduce to a minimum the technical aspects and mathematical requirements. No prior exposure to these topics will be assumed.

Exams: No exams will be given. Nonetheless, participation in these lectures will be essential for passing the course.

Homework: There will be homework problems given but not collected for grading. You are encouraged to discuss the homework problems with your classmates and to work together. You are highly encouraged to ask questions in class.
